The law is **not** "woolly" or "confused." When a parent asks the school to take the child's name off the school roll, the school just needs to check the Pupil Registration Regulations and follow the directions for what to do next. There is no need to ask the council for guidance or to heed a council which advocates the school's breaking the law.
