Pupils with a statement

The Statutory Review of a SEN Statement for an Electively Home Educated child is also to include an annual review of that child's Elective Home Education provision. The review will be called and administered by the SEN Assessment and Review Team. The monitoring officer should contribute to the review. Preferably the review will take place in the family home with the SEN Officer and Elective Home Education Team member in

attendance.

School Action Plus

Pupils who had been on a school roll and who had received school action plus in relation to special educational needs may continue to receive support from the Local Authority in relation to his/her identified needs. This is not a statutory obligation but may be regarded as good practice. For any Local Authority support to be practicable, the parent will need to engage with officers and allow monitoring activity.
