From September 2013 home educated young people aged 14-16 in England are able to attend college part-time or full-time and the Government will pay for the course. There are 4 funding bands. It is up to the colleges whether or not to admit under-16s. These students can do any course agreed by the college, not just a designated 14-16 course, although many colleges still don't offer GCSE courses. The rules are different for home educated young people because the parent retains responsibility and so the college does not have to make special arrangements for pastoral care or offer a full curriculum. DfE says arrangements are between the parents and the college and do not need to involve the local authority at all."

DfE says "students can only be enrolled at one institution (the "home" institution), and that one institution takes on the responsibility for claiming all the relevant funding for the student. So, if a home-educated student wants to take courses at more than one college, then the college where the majority of learning is taking place has to take the responsibility to be the "home" institution and claim all the funding for the student, then pass across the relevant part to the other college(s) involved. There would have to be some agreement between the colleges ahead of the funding claim, for this to be able to happen."

In addition DfE says "for home-educated students, there are no age restrictions for funding purposes, it is for the college to decide whether they wished to take younger students onto their courses. If they agree to take a younger home-educated student onto their courses, then we will fund in the usual way."

Where a home educated 14/15 year old needs additional support, the college enters this information on the ILR in November and it will count towards the amount which the college receives in lagged funding next year. Where the student has <u>low to moderate additional support needs</u> the unique determining factor for funding eligibility will be the individual student's postcode (<u>disadvantaged uplift postcode dataset</u>). Where a home educated 14/145 year old has <u>high additional support needs</u>, the college will ask the LA for a top for the current academic year, record this on the ILR, and receive an additional £6K the following year.

## Annex C: Electively home educated 14 to 15 year-olds

1.

Colleges sometimes admit children aged 14 or 15 who are being electively home educated, to take courses on an infill basis by arrangement with the local authority or with the parents. Where these courses are at level 3, they are funded by entering the student on the ILR and the student then counts for lagged funding in just the same way as if they were aged 16- to 18-years-old.

2.

Prior to September 2013, students on courses below level 3 were funded either directly by the local authority, or sometimes by the parents, paying a fee to the college. These arrangements changed with effect from September 2013. Colleges now enter these students on the ILR and they count towards the college's student numbers for lagged funding in the following year. Local authorities and parents should no longer be expected to pay fees for this provision.

Colleges make such local arrangements as they deem appropriate. There is no national prescribed model for provision to these students and they do not form a part of the arrangements for the full time enrolment of 14 -16 year-olds in Further Education and Sixth Form. # Positive Developments 14-16s College

Exceptionally some colleges are offering GCSE courses but this is by no means standard. Colleges may require students starting A Level courses to have a minimum number of GCSEs (or IGCSEs as equivalent) before they are accepted onto the course.

## **Summary Funding**

Overview of 16+ funding All full time students will be funded at the same basic funding rate per student, per academic year regardless of which type of institution and what they study. This will fund a full study programme for all students. Initially part time students will be funded based on four bands depending on the number of teaching hours for which they enrol. In 2013/14, as a transitional measure, the Government will fund individual students who re-take qualifications. Subsequently re-takes will not generally be eligible for funding. See also "block two – support needs for progression" (page 24-5) additional funding to support all students without maths and English at grade C.

### **Summary Wolf Report**

The Wolf Report on Vocational Learning in **England** was published in March 2011. Alison Wolf said that the young person's programme of study should provide for labour market and educational progress and that the system needed to be simplified dramatically to encourage innovation and efficiency. With the publication of DfE's <u>response to the consultation on 16-19 study programmes and plans for implementation</u> on July 3rd 2012, most recommendations relating to post-16 study were incorporated into DfE's plans for 2013 onwards. The final point was direct admission to colleges for 14-16s confirmed on November 5th, with further details added by DfE on December 13th/14th 2012.
